In accordance with Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with Schedule III to the said Regulations, we hereby inform you that, the Board of Directors (the "Board") of White Organic Retail Limited (the "Company") at their meeting held today i.e., December 02, 2024, commenced at 05.30 p.m., inter alia:

- a) Considered and approved the Increase in Authorised Share Capital of the Company from Rs. 33,00,00,000/- (Rupees Thirty-Three Crore Only) divided into 3,30,00,000 Equity Shares of Rs. 10/- to Rs. 83,00,00,000/- (Rs. Eighty-Three Crore Only) divided into 8,30,00,000 Equity Shares of Rs. 10/- each by creating additional Rs.50,00,00,000 /- (Rs. Fifty Crore Only) divided into 5,00,00,000 Equity Shares of Rs. 10/- ranking pari passu in all respects with the existing equity shares of the Company and Alteration of the Capital Clause of the Memorandum of Association, subject to approval of the members.
- b) Approved the Issue and Offer of Equity Shares on Rights Basis for an aggregate amount not exceeding Rs. 49,99,99,999/- (Rupees Forty-Nine Crores Ninety-Nine Lakhs Ninety-Nine thousand Nine Hundred and Ninety-Nine only) to the eligible equity shareholders of the Company as on the record date (to be determined in due course) subject to receipt of necessary statutory/ regulatory approvals, as may be applicable.
- c) Approved the appointment of Ms. Najama Husen Shaikh as Chief Financial Officer of the Company w.e.f. December 02, 2024.
- d) Approved the appointment of Mr. Syamdas Sivadas as Managing Director of the Company for a period of 3 (three) years w.e.f. December 02, 2024, subject to approval of the members of the Company.
- e) Approved the appointment of Ms. Pooja Gandhi (ACS 75075) as Company Secretary and Compliance Officer of the Company.
- f) The 13th Annual General Meeting of the Company will be held on Saturday, December 28, 2024, at 02:45 p.m. through Video Conferencing ("VC')/ Other Audio-Visual Means ("OAVM"). The cut-off date for the same shall be intimated in due course.
- g) Approved the draft Notice of the Annual General Meeting.
